Re: Summer Feeding Sites

Summer Feeding for Mobile County Schools will begin on Monday June 4, 2018 and continue through Thursday, July 19, 2018. Meals at no charge for children 18 and under will be available Monday through Thursday with the exception of July 4, 2018. All meals must be eaten on site in the designated areas of the school.

Children will be able to enjoy a meal at the following sites between the hours of 10:30 a.m. until 12:30 p.m. in the school cafeteria no carryout.

Lunch and breakfast will be served beginning June 4 through July 19 at Augusta Evans and Leinkauf Elementary.

Lunch only will be available from June 4 through July 19 at Robbins and Spencer-Westlawn elementary schools and Baker, Blount, LeFlore and Vigor high schools

Lunch and breakfast will be offered on an abbreviated schedule from June 4 through July 19 at Craighead and Gilliard elementary schools and Pillians Middle, and from June 11 through July 19 at Hankins and Lott Middle and Kate Shepard Elementary.

The Super Food Express will also be back this year, with buses bringing meals to non-school sites including: Highpoint Park in Eight Mile, Freewater Baptist Church in Irvington, Rickarby Park in Mobile and William Clark Recreational Center in Prichard.
